



Since few years by now, BonelliErede counted on developing a strong Africa and Middle East practice: our aim is to become a strategic hub able to capture, support and safeguard investments in Africa and the Middle East and maximise the value for international investors, local businesses and governments.

We currently have four strategic outposts: Cairo (Egypt) in cooperation with Bahaa-Eldin Law Office, Addis Ababa (Ethiopia) in cooperation with Tameru Wondm Agegnehu Law Office, Dubai (United Arab Emirates), and Beirut (Lebanon) as part of the integration of the law firm Tribonian Law Advisors.

We made our first step in the region in 2016 by entering Egypt and Ethiopia in partnership with local law firms. In Egypt, we recently reinforced our presence through a new, stronger partnership: effective as of 1 July 2018, we cooperate in Egypt with the local law firm Bahaa-Eldin Law Office and we can boast an integrated team of a ten Egyptian and Italian lawyers based in Cairo. In Ethiopia, similarly to Egypt, we have an integrated team of a ten Ethiopian and Italian lawyers based in Addis Ababa.

Effective as of 1 July 2018, our presence in Dubai boasts the integration of Tribonian Law Advisors (TLA), a new generation boutique law firm that has been providing clients expert legal advice in M&A, corporate finance and corporate and commercial law throughout the Middle East through its offices in the United Arab Emirates, Lebanon and - through an alliance with a local law firm - Saudi Arabia.

TLA has always been recognized as an M&A specialist and has been involved in a number of landmark deals, on cross-border transactions, joint ventures, finance deals in several jurisdictions across the Middle East and Africa.

Our local team has assisted regional and international clients on the full spectrum of the M&A deals, joint venture, and private equity, in various industries and sectors throughout the GCC region.

Our office in Lebanon is composed of a team of 10 professionals and business support staff and is an heritrage of the recent integration of Tribonian Law Advisors (TLA), which was present in the country since 2011.

In Saudi Arabia, we have a partnership with Al Kheraiji Lawyers & Consultants, a leading Saudi law firm delivering client-centered legal services across a broad range of industry sectors. The firm offers a wide spectrum of legal services to corporate and individual clients and has a proactive approach towards finding legal solutions to problems as they arise. Kheraiji Lawyers & Consultants led by Abdulaziz Al Kheraiji has a significant knowledge and extensive experience in the field of legal practice in Saudi Arabia.

In addition, we have built – and are continuing to strengthen – a network of leading local law firms in the region and we currently have cooperation in key jurisdictions in North Africa (Morocco, Tunisia, Algeria) and in Sub-Saharan Africa (Kenya, Nigeria, Tanzania, Ghana, Mozambique).

Leveraging also on TLA's track record in the region, we can boast at least one mandate in 23 countries in Africa and Middle East.



Besides advising businesses and investors in Africa & Middle East, we are also carving out a key role in the region's future legal landscape: for instance, we are advising a number of African governments on legislative reform in the energy, banking and corporate sectors to further stimulate foreign investments.

In line with the best international practices, we have also launched a Focus Team on Public International Law & Economic Diplomacy, which integrates Angelino Alfano's skills with those of the professionals who have been

advising for years on Public International Law, including anti-corruption, international arbitration, legal reforms, tax and regulatory. The founder of the firm, **Tameru Wondm Agegnehu**, has been practicing since 1992 and served as Vice President of the Supreme Court in Ethiopia between 1988 and 1991; he is considered an institution in the local legal community and the main international legal directories have always ranked him at the top of the domestic market, with unanimous recognition from both clients and competitors alike. Tameru Wondm Agegnehu is flanked by **Mahlet Kassa Woldesenbet** and **Robel Tsegaye Mehari** both corporate law senior associates and two junior associates.

The firm provides innovative, client focused advice on contracts law, investment, corporate, commercial, construction law, energy law, employment law, intellectual property including patent, trademark and copyright law, and international arbitration and litigation.

We are also working with the College of Law and Governance Studies at Addis Ababa University to identify possible legislation reform in Italy and Ethiopia to improve industrial and financial relations and increase foreign investment.

The team has been active on numerous matters assisting foreign investors in Ethiopia and have participated in numerous initiatives in the country, including seminars, events and roundtables dedicated to Sub-Saharan Africa and business opportunities in the Horn of Africa. Getting a stronger presence in North Africa represents the natural evolution of the path started with our outpost in Egypt. We are focusing on developing strong relationship with major law firm in **Libya**, **Algeria**, **Tunisia** and **Morocco**.

East Africa is a key area of development and we are already working in with full service law firms in **Kenya** and in **Tanzania**. Furthermore, in 2017 we issued a Doing Business in Tanzania report, with a focus on tax issues.

Beyond North and East Africa, we have relationship with leading tier-1 law fim in **Nigeria** and in **South Africa** in which we are active since 2015.

South Africa is one of the countries we focus on the most besides North and East Africa, because we deem it strategic for our development on the continent, in the light of its pivotal role in Sub-Saharan Africa's economy and development. We are active in South Africa assisting Italian and international clients interested in investing in the country. We are also collaborating with Italian institutions in South Africa, such as the Consulate, the Chamber of Commerce, ICE, and SACE, and we were main partners of The European House Ambrosetti in their Italy-South Africa annual Forum. In 2015 we have prepared a guide for Italian and international companies interested in South Africa, the "Doing Business in South Africa", and from 2015, we have a friendship with a tier 1 law firm.

We have also followed and organized manifold initiatives in Italy with focus on South Africa, including:

- the "International Conference on Children in Protracted Crises "A New Perspective" - which will take place on 16 June 2017 in Genoa - in collaboration with the Embassy of The Republic of South Africa and the Honorary Consul of South Africa in Genoa, and with the patronage of The Ministry of Foreign Affairs, and the main Genoese institutions;
- the round table "Corporate law's perspective in South Africa: joint ventures and international investment agreements" on 3 November 2016 in collaboration with the Milan Lawyers Association;
- The BonelliErede Art and Cultural Property Focus Team has partnered with the South African pavilion at the 2017 Venice Biennale.

Also **Mozambique** is a country of interest for us since the beginning of our project. In 2014 BonelliErede was the only law firm present on the business trip to Mozambique organised by Confindustria, with the collaboration of the Ministry of Foreign Affairs and Economic Development.

The initiative, spearheaded by the Deputy Minister of Economic Development, Carlo Calenda, was dedicated to agro-industry, infrastructure and energy – sectors that offer substantial opportunities and was focussed on identifying the business opportunities for Italian firms and local businesses.

We are now working to develop relationship with a relevant tier-1 local law firm.

Corporate and M&A

Africa is experiencing a steep and constant increase in M&A levels: from 2009 seeing only 86 M&A deals involving Africa targets, to 2017 seeing 249 – with the vast majority being international deals. International private equity firms continue to go from strength to strength in Africa evidence by the total deals value of \$4.4 bn in 2017 versus \$3.8 bn in 2016.

The Middle East region is increasingly becoming an easier place to do business, an easier place for foreign direct investment, and a more attractive destination to invest. The value of mergers and acquisitions with Middle Eastern involvement reached \$88.3 billion in 2017, in line with 2016 levels, according to the latest reports. The value of inbound cross-regional deals targeting the Middle East increased significantly by 194% to US\$1.9 billion in Q4 2017 from US\$630 million in the previous quarter. By value, outbound cross-regional deals from the Middle East increased by 52% in Q4 2017 to US\$2.3 billion compared to US\$1.5 billion from the previous quarter.

Against this background, foreign businesses need the support of lawyers with remarkable experience in large and complex cross-border deals. Our multidisciplinary, international team are experts in managing, in close collaboration with decision makers and financial advisors, the structuring and execution of complicated, high stake cross-border deals involving African countries — particularly those that require sophisticated legal planning and outstanding legal judgment. In the ever-evolving world of M&A, we continue to make a real contribution to the success of each deal. Our ability to come up with

groundbreaking solutions and deliver optimum results is renowned – some of the most innovative structures conceived by our lawyers have become market standards.
