A NEW Era of FDI in China

Original "Three FIE Laws" to be repealed at end of 2019 and replaced with new Foreign Investment Law (FIL) to take effect 1 January 2020.

NEW Corporate Governance

All foreign investment enterprises (FIEs) now to be governed by corporate governance requirements under the Company Law.

New FIL affects not only all new FIEs but also all 500,000+ existing FIEs, which will need to convert to LLCs under the Company Law before the end of 2024.

NEW FDI Documentation

Legacy JV contracts which conformed to the old laws to be replaced by new agreements that incorporate the provisions of the Company Law and international best practices.

NEW Standard for the China Market

The expert committee invested more than 1,000 hours to create almost 250 pages of new bilingual templates and annotations.
